## Terms and Conditions

By making a deposit, or receiving receipt for booking, you agree to the terms & conditions listed herein:

-

## Payments & Refunds:

- Partial payment to secure booking. We accept credit card, cash, cashiers check, and personal checks. Some forms of payment may require processing of 3 business days or more.
- Full payment is required before your trip departure and all money is non-refundable once the bus is en-route and available for work.
- To receive a refund of your deposit, cancellations must be presented by email or text at least 10 days prior to your scheduled Vip Party Bus Trip. Any fees incurred for processing of payments will not be refunded back to you, unless they are refunded back to us during processing time. After the 10 day window to cancel has expired, an Administrative fee of \$150 will charged against any deposit we have on file.
- InnerPrizin LLC/VIPPARTYBUSSPOKANE reserves the right to cancel service or evict passengers at any time for contract breaches, incidents of property damage, threatening behavior, abuse, illegal activities, or any actions that pose a threat to the business, its passengers, or the driver. If the driver is forced to terminate service, all passengers will be dropped off at the nearest and safest location. The driver will not refund any payments or tips, and a report will be made of each incident & kept on file for 30 days.
- InnerPrizin LLC/VIPPARTYBUSSPOKANE has the right to continue or end security surveillance at any time.

## Renter Eligibility:

Renter must be 18 years of age or older. Any children under 14 years of age, must be accompanied by a chaperon, unless approved otherwise.

## Renter Responsibilities:

Limited liability waiver/ You, the renter are responsible as the "Social Host" for all passengers & activities on board. The main responsibility of InnerPrizin LLC/VIPPARTYBUSSPOKANE is to drive safely, avoid hazards, & create a positive experience for your group.

## Alcohol Policy:

NO UNDER AGE DRINKING IS ALLOWED & IS AGAINST THE LAW. No glass beer bottles or kegs will be allowed. Please only bring cans, plastic cups/containers, liquor bottles & wine bottles when alcohol is permitted.

Damage Policy:

Absolutely no smoking while onboard. If the driver finds any damage due to cigarette burns, fire damage, vomit, or other bodily fluids, a minimum of \$150 will be required to resume the trip.

Lost or Stolen Items:

Neither InnerPrizin LLC/VIPPARTYBUSSPOKANE, its affiliates, or the driver are responsible for lost or stolen items.

Driving conditions:

- If conditions are deemed to be unsafe, the Client will be contacted with as much notice as possible. Any cancellations where InnerPrizin LLC/VIPPARTYBUSSPOKANE has decided to cancel due to weather will be eligible to reschedule at the next available date, or will receive a full 100% refund. The customer does not make the final decision on whether or not weather will permit service.
- InnerPrizin LLC/VIPPARTYBUSSPOKANE does not guarantee arrival at, or departure from any point at a specific time due to circumstances beyond its control such as accidents, breakdowns, traffic and road conditions, storms, etc. & shall not be held liable for claims resulting in delays from such conditions. You agree our company will not be held responsible for delays/inconveniences due to unknown and/or unforeseen mechanical failures or situations deemed as "Acts of God." provided we have used reasonable efforts to avoid delay.

Medical Waiver:

InnerPrizin LLC/VIPPARTYBUSSPOKANE will not be held responsible for any incidents causing the need for medical attention including alcohol poisoning, slips & falls, bodily injury, photosensitive epilepsy, breathing/heart problems, headaches, claustrophobia, or any other conditions unknown to our staff.
